

**RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK AND INDEMNITY AGREEMENT  
KIDS'/YOUTH SHOTOKAN KARATE CAMP, MAY 25-26, 2019**

IN CONSIDERATION of me or my son, daughter or minor child of whom I am the legal guardian ("Child") or both being permitted to compete, officiate, observe, work for, or participate in any way in the Kids'/Youth Shotokan Karate Camp (the "Camp") or of either or both of us being permitted to enter into for any purpose any area in which any part of the Camp is conducted or any area which is connected to the Camp (including, without limiting the generality of the foregoing, travelling to and from the Camp before and after the Camp) (collectively, the "Event"), THE UNDERSIGNED, for him- or her-self, the Child, and their respective personal representatives, heirs, and next of kin:

1. Acknowledges, agrees, and represents that immediately upon entering any area connected to the Event, and continuously thereafter, both of us will inspect the area and I further agree and warrant that, if at any time, either of us is in or about such an area and feel anything to be unsafe, we will immediately advise the leaders of the Event of such and will leave the area and/or refuse to participate further in the Event.

2. HEREBY RELEASES, WAIVES, DISCHARGES AND COVENANTS NOT TO SUE the leaders or officials of the Event, the other participants, Canada Shotokan Karate, Canada Shotokan Karate Society, Shotokan Karate of America, the promoters, participants, sanctioning organizations or any subdivision thereof, operators, owners, officials, sponsors, advertisers, owners and lessees of premises used to conduct the Event, premises and Event inspectors, surveyors, underwriters, consultants and others who give recommendations, directions, or instructions or engage in risk evaluation or loss control activities regarding the premises or the Event and each of them, their directors, officers, agents, and employees, (all for the purposes herein referred to as "Releasees") FROM ALL LIABILITY TO THE UNDERSIGNED OR THE CHILD OR BOTH, their respective personal representatives, assigns, heirs, and next of kin FOR ANY AND ALL LOSS OR DAMAGE, AND ANY CLAIM OR DEMANDS THEREFOR ON ACCOUNT OF INJURY TO THE PERSON OR PROPERTY OR RESULTING IN THE DEATH OF THE UNDERSIGNED OR THE CHILD OR BOTH ARISING OUT OF OR RELATING TO THE EVENT, WHETHER CAUSED BY THE NEGLIGENCE (WHETHER SIMPLE OR GROSS) OF THE Releasees OR OTHERWISE.

3. HEREBY AGREES TO INDEMNIFY AND SAVE AND HOLD HARMLESS the Releasees and each of them FROM ANY LOSS, LIABILITY, DAMAGE, OR COSTS they may incur arising out of or related to the Event WHETHER CAUSED BY THE NEGLIGENCE (WHETHER SIMPLE OR GROSS) OF THE Releasees OR OTHERWISE.

4. HEREBY AGREES that karate is in inherently risky activity which could result in serious injury or even death and ASSUMES FULL RESPONSIBILITY FOR ALL RISK OF BODILY INJURY, DEATH OR PROPERTY DAMAGE arising out of or related to the Event whether caused by the NEGLIGENCE (WHETHER SIMPLE OR GROSS) OF Releasees or otherwise.

5. HEREBY acknowledges that THE ACTIVITIES OF THE Event MAY BE DANGEROUS and involve the risk of serious injury or death or property damage or any one or more of them. The UNDERSIGNED also expressly acknowledges that INJURIES RECEIVED MAY BE COMPOUNDED OR INCREASED BY NEGLIGENT (WHETHER SIMPLE OR GROSS) RESCUE OPERATIONS OR PROCEDURES OF THE Releasees.

6. HEREBY agrees that this Release and Waiver of Liability, Assumption of Risk and Indemnity Agreement extends to all acts or negligence (WHETHER SIMPLE OR GROSS) by the Releasees, INCLUDING NEGLIGENT (WHETHER SIMPLE OR GROSS) RESCUE OPERATIONS and is intended to be as broad and inclusive as is permitted by British Columbia law and that if any portion thereof is held invalid, the balance shall continue in full legal force and effect.

7. HAS READ THIS RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK AND INDEMNITY AGREEMENT, FULLY UNDERSTAND ITS TERMS, UNDERSTANDS THAT I HAVE GIVEN UP, FOR EACH OF MYSELF AND THE CHILD, ESSENTIAL LEGAL RIGHTS BY SIGNING IT, AND HAVE SIGNED IT FREELY AND VOLUNTARILY WITHOUT ANY INDUCEMENT, ASSURANCE, OR GUARANTEE BEING MADE TO EITHER OF US. I INTEND MY SIGNATURE TO BE A COMPLETE AND UNCONDITIONAL RELEASE OF ALL LIABILITY TO ME OR THE CHILD OR BOTH TO THE GREATEST EXTENT ALLOWED BY LAW. I understand that I am not required by law to sign this Release, that the Child and I are each permitted to participate in the Event only because I have agreed to sign it, and that the Releasees are relying on my signing it in allowing either of us to participate in the Event.
